### *The Dream Deferred Podcast*, Season 1, 5 episodes

This podcast series was produced by the Technologies for Justice Lab, founded at UC Santa Barbara in 2022. This series was recorded in a graduate seminar co-taught by Lisa Parks, France Winddance Twine and Kim Yasuda in the Fall term of 2021 at UC Santa Barbara.
